Biddy Mason Celebrates First Anniversary in New Home

The Biddy Mason Charitable **L** Foundation, one of our ministry partners, recently celebrated the first anniversary in its new location in the Kinney Heights neighborhood of Los Angeles.

The location that Biddy Masson now calls home was purchased by CLH as a new home for Biddy and rented it to them for \$10 a month. "We don't think of CLH as our landlord," said Jackie Broxton, executive director of Biddy Mason. "They're our collaborative partner."

"Having a permanent home changed our whole trajectory," added Broxton who had been working from her

garage since co-founding the organization in 2013 to support foster youth. "CLH has a commitment to ending homelessness, and their purchase of this property gave us a beautiful place to do our work, host foster youth for events, or just let them hang out," she said.

This unique CLH and Biddy Mason partnership is a good collaboration. The needs of foster youth are growing in the Los Angeles area. With more than 30,000 children and teens in foster care, it's the largest program in the country. Foster children and former foster youth are in crisis, according to Broxton, who said approximately 9,000 new cases are evaluated each month

The house also has an apartment where Biddy Mason plans to let four female college students live after the pandemic abates. The organization hosted its annual scholarship awards presentation in July, and a new event, The Exchange, last October, inviting youth to eat a meal together, play games, watch movies, talk, and hang out.

Biddy Mason grew out of a desire of members of First AME Church of Los Angeles and the greater Los Angeles community to provide support to foster youth. The Foundation is a 501c3 independent nonprofit.

CLH Partners with Living the Resurrection for Congregational Vitality



Congragations working the process

Tn November, CLH begins a collaboration with Living the **Resurrection**, a vitality initiative to help Southern California pan-Lutheran congregations thrive through processes, workshops, keynotes, consultations, and coaching.

CLH funds the cost of a Living the **Resurrection vitality program to** make it more accessible to smallto-medium-sized congregations. The funding covers everything except a small materials fee. This congregational process helps churches explore the passions and struggles they face in diverse and changing neighborhoods. CLH funding will reduce the cost of the program for congregations in the Southwest California and Pacifica synods of the Evangelical Lutheran Church in America (ELCA), and the **Pacific Southwest District of the** Lutheran Church-Missouri Synod (LCMS).

The Living the Resurrection program provides eight workshops over 18 months to help congregations discern where God

is building connections, along with developing momentum for change, according to the Rev. Dr. Marjorie Funk-Pihl of the ELCA, founder and facilitator.

"CLH's mission is to support Lutheran congregations in the regions we serve," said CLH **President and CEO Deacon Nancy** Ackerman. "Our funding of Living the Resurrection is designed to help congregations be more vital and better equipped to do God's work in their neighborhoods."

Pastor Funk-Phil developed Living the Resurrection while serving the Southwest California Synod as director for Evangelical Mission. Although she had led mediumsized congregations for more than 20 years, she was challenged by how to help smaller monocultural congregations located in large multicultural neighborhoods. She created Living the Resurrection to help these congregations.

"Many of our congregations are in buildings designed for 150 to 200 people, but often have 30 to 50 people in worship on a Sunday," said Pastor Funk-Pihl. "We want to help these congregations be more relevant and vital. Many congregations want to learn how to change but have little access to resources that will help them. We're blessed and thankful to CLH for making this available.³

Is a Charitable Gift Annuity **Right for**

You?

D id you know that your donation could be beneficial to both you and CLH? A charitable gift annuity lets you accomplish just that. This type of gift is a win-win because you benefit, too. You can leave a legacy to an organization that is close to your heart and supplement your own income.

When you give a charitable gift annuity, CLH invests it in a separate account. In return, you receive a fixed monthly or quarterly payout from the investment account for your entire life. The payout amount is based on your age at the time of the gift. At the end of your life, the remainder of the gift goes to CLH.

In addition to the income stream, a tax deduction at the time of the original gift may be available. The deduction is based on the estimated amount that will eventually go to CLH after all annuity payments are made. A portion of the payments you receive may also be tax-free for a period of time based on statistical life expectancy.

In general terms, a charitable gift annuity allows a donor to make a generous gift to a nonprofit with cash, securities or other assets. The donor takes a partial tax deduction for their donation and receives a fixed income stream from the investment for the rest of their life.
