#### A Message from the President & CEO

The legacy of Grace Lutheran Church in Santa Barbara, which closed in 2015 after membership declined, continues to help people in need of affordable housing.

When Grace closed, it gifted its land to CLH, with the vision of affordable housing being preserved at the site. With the gift, CLH partnered with the Housing Authority of Santa Barbara (HASB) to build Grace Village, a 58-unit low-income, senior affordable housing complex. In December, CLH made a second piece of property available, and again, in partnership with HASB, will develop Grace Village II, a second lowincome senior housing development on the site.

# Affordable Housing at Hollywood West

Built in the 1920s, Hollywood West Apartments are 84 units of rental property in south Hollywood surrounding Paramount Studios. The five buildings are in the style of the Golden Age of Hollywood, and home to approximately 150 people. They're owned by a non-profit whose mission is to raise the economic, educational, and social levels of minority communities that are unemployed, underemployed, or living below federal poverty guidelines.

When Hollywood West began pursuing a \$13.9 million rehabilitation, the non-profit asked CLH for help with pre-development "soft costs" associated with obtaining a new HUD/FHA loan. Soft costs include architectural, application, permit, legal, and inspection fees, among other emergent needs. Without CLH's pre-development loan, Hollywood West couldn't qualify for the HUD/FHA loan.

"The result of continued physical project decline would be that more than 100 low-income people would eventually be out on the streets with nowhere to live. California Lutheran Homes has provided the means to save Hollywood West."

CLH's mission to provide funding and other assistance for affordable housing is often fulfilled in the pre-development phase. Its partnerships with non-profits such as Hollywood West ensure that decent,



safe, and sanitary housing is available for low-income persons and families who otherwise wouldn't be able to afford a place to live.

When CLH's CEO Deacon Nancy Ackerman asked what other organizations Hollywood West was considering for partnership, the organization responded: "We don't know anyone else who will help us with these costs." Deacon Ackerman says she hears that a lot. "That's why CLH's work in affordable housing is vital today," she said.

She added: "Housing is an internationally recognized basic human right (United Nations 2014.) The dignity and security of a stable home offers benefits that go far beyond the provision of shelter, including health stabilization and improvement, and increasing income. The core of CLH's mission is to provide housing and other assistance to those who are most vulnerable. The Hollywood West project keeps people in their homes and provides security for generations to come."

Since Grace bravely stewarded it's legacy as it faced closure, CLH has assisted other congregations facing financial and membership challenges, and closure. In the past few months alone, we've received several cries for help from congregations.

In a recent article on U.S. religious trends in the Pew Research Center 's Pew Trust Magazine, David O'Reilly predicts that 47 percent of the population will be Christian by 2050, and less than 39 percent by 2070.

This trajectory implies that many Lutheran congregations will likely struggle with sustainability over the next few decades. # The Benefits of an IRA Charitable Rollover



I f you are age 72 or older, you may be eligible for the Individual Retirement Account (IRA) Charitable Rollover, which allows you to make a gift to California Lutheran Homes from your IRA without paying income tax on the amount transferred. You're allowed to transfer up to \$100,000 per year to satisfy your Required Minimum Distribution. The rollover must be from your IRA; rollovers from other retirement plans such as 403(k) and 403(b) do not qualify. The rollover is made by instructing your IRA plan administrator to transfer funds directly from your IRA to CLH.

If you're not in a position to consider an IRA Charitable Rollover during your lifetime, leaving IRA and other retirement plan assets to CLH at your death will shelter those assets from erosion due to income taxes and estate taxes. This is accomplished by simply naming California Lutheran Homes as a beneficiary of all or a percentage of your IRA/retirement plan using a Beneficiary Designation Form, which can be obtained from your IRA plan administrator.

It's always wise to consult with your tax adviser for specific information.
